CHANGES TO PRE-ARRIVAL NOTIFICATION FROM 1 JANUARY 2025

- 1. This circular supersedes Port Marine Circular No. 11 of 2022 and provide updates on the changes to the Pre-Arrival Notification (PAN).
- 2. From 1 Jan 2025, the Maritime Singapore Green Initiative (MSGI) will be enhanced. The incentives for ocean-going vessels previously under GPP will be integrated under the enhanced Green Ship programme (GSP) Green Port component.
- 3. To qualify for port dues concession¹, the master of every ship, craft or unit calling at the Port of Singapore must register under the Green Ship Programme Green Port component and declare the fuel/technology used throughout the entire duration of port stay in Singapore in the revised PAN.
- 4. PAN has also been revised for the reporting of compliance with Ballast Water Management Convention (BWMC). Vessels are now only required to indicate for a valid BWMC Certificate or Statement of Compliance, and the operational status of the Ballast Water Management System (BWMS), if applicable.
- 5. Pursuant to Section 44(1), (2) of the Maritime and Port Authority of Singapore Act (Cap. 170A), and Regulations 3 and 63A of the Maritime and Port Authority of Singapore (Port) Regulations, the Port Master hereby directs owners, masters or agents of vessels to furnish the required information using the revised PAN form. ANNEX A delineates the types of vessels to which the revised PAN is applicable, and the revised PAN form is provided in Appendix 1.
- 6. There are no alterations to the requirements or reporting format of the Notification of Arrival (NOA) for vessels under 500 Gross Tonnage (GT), as outlined in ANNEX B.

¹ The vessel must first be registered under the GSP – Green Port through the digitalPORT@SG[™] prior to arrival in Singapore; and subsequently declare the participation in the programme via PAN before arrival into Singapore.

PRE-ARRIVAL NOTIFICATION (PAN)

The revised Pre-Arrival Notification (PAN) form must be submitted by the owner, agent, or master of the following vessels:

- a) Passenger ships, including high-speed passenger craft;
- b) Cargo ships, including high-speed craft, of 500 Gross Tonnage (GT) and above; and
- c) Mobile offshore units, including mobile offshore drilling units.
- The revised PAN form is attached in **Appendix 1** for reference and will be available for download at the URL https://go.gov.sg/ePAN from 28 Dec 2024. Owners, agents, or masters are required to use the revised PAN form for all vessel arrivals on or after 1 Jan 2025.
- The completed PAN form must be submitted to the Port Security Unit via email at isps@mpa.gov.sg at least **24 hours** prior to the vessel's arrival in Singapore. Vessel agent(s) who are based in Singapore may submit the PAN through digitalPORT@SGTM (https://digitalport.mpa.gov.sg) from 1 Jan 2025.
- 4 Once the PAN has been submitted for a vessel, submission of a separate Notice of Arrival (NOA) is **not** required.

NOTIFICATION OF ARRIVAL FOR VESSELS LESS THAN 500 GT

The owner, agent, master or person-in charge of a vessel of under 500 Gross Tonnage (GT) shall notify the Port Master at least 12 hours prior to the vessel's arrival in Singapore.

- The Notice of Arrival (NOA) report shall be addressed to the Port Master and must include the information outlined in the reporting format as shown in Appendix 2. The NOA can be transmitted though one of the following methods:
 - a) Upload via digitalPORT@SGTM (https://digitalport.mpa.gov.sg); or
 - b) Send via email to noa@mpa.gov.sg; or
 - c) Send via Telefax to +65 6224-5776.
- 3 For vessels returning from a location in the Singapore Strait, the NOA may be transmitted via VHF radio immediately upon the vessel's departure from the location.
 - a) For vessels in the VTIS East sector, the NOA shall be transmitted on VHF Channel 10:
 - b) For vessels in the VTIS Central sector, the NOA shall be transmitted on VHF Channel 14:
 - c) For vessels in the VTIS West sector, the NOA shall be transmitted on VHF Channel 73
