BULK CARRIER OPERATIONS AT TUAS TERMINAL PHASE 2 PROJECT AREA

Applicable to: Mariners operating Off Temasek Fairway and in the vicinity of Tuas Terminal

This is a revision of Port Marine Notice No. 54 of 2024. The working period has been extended.

Date : With effect from 20 Jan 2024 to 20 July 2025.

Location : At Tuas Terminal Phase 2 project area, within the working area bounded by the following co-ordinates (see attached chartlet):

<u>Details</u>	:	During this period, bulk carriers, self-propelled barges and pusher tugs with barges in composite unit carrying sand will be transiting the Temasek Fairway to the Tuas Terminal Phase 2 Finger 3 reclamation project area.	
		A safety tug will be in attendance at all times to warn and re- direct craft in the vicinity to keep clear of working area.


