A safety tug will be in attendance at all times to warn and re-direct craft in the vicinity to keep clear of working area.

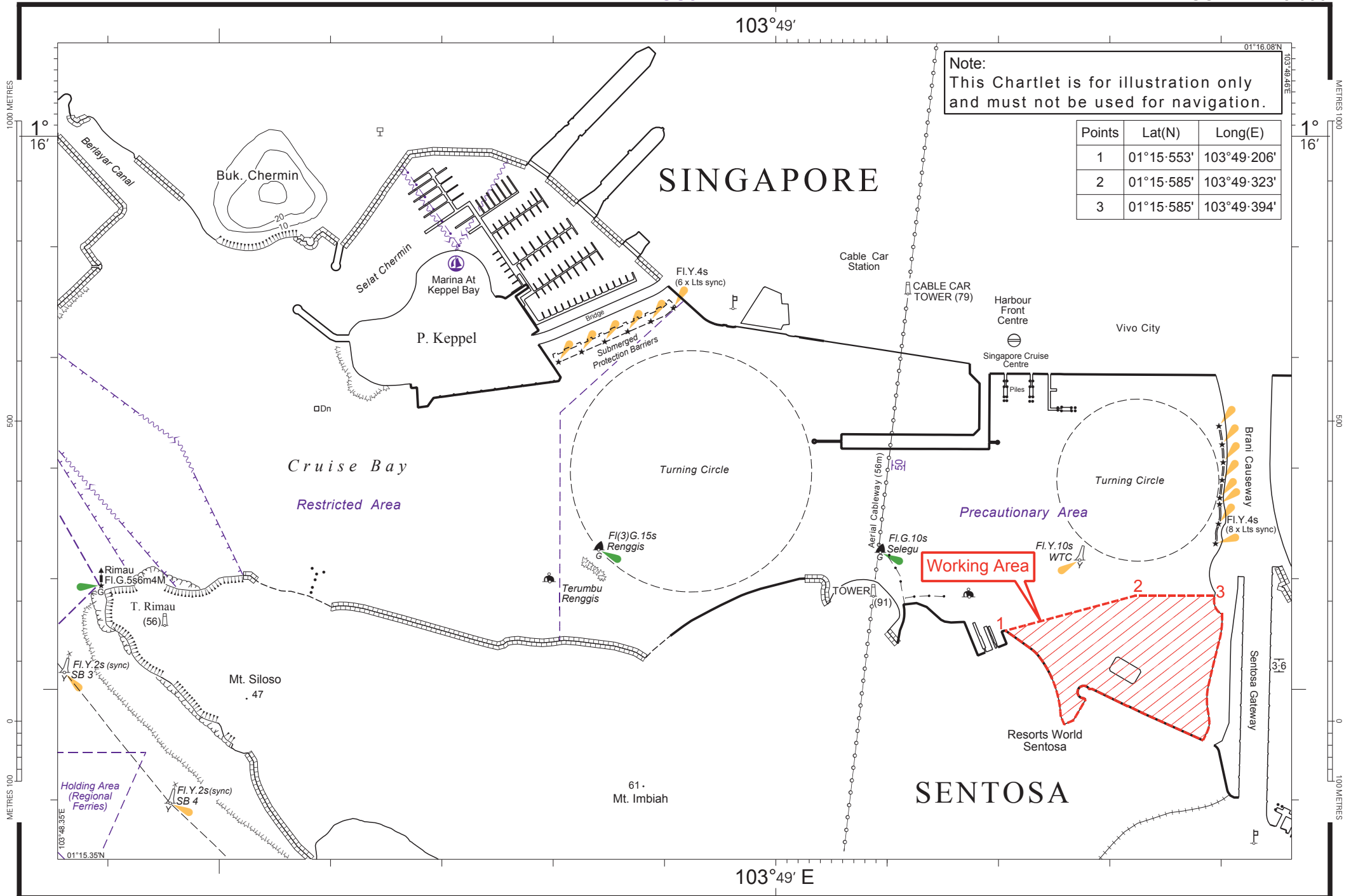
