Implementation of eGuarantee@Gov Platform for Security Deposits

The Immigration & Checkpoints Authority of Singapore (ICA) recently embarked on the eGuarantee@Gov Initiative launched by the Ministry of Finance (MOF) and Monetary Authority of Singapore (MAS) for application/renewal of security deposits (SDs).

The eGuarantee@Gov is an initiative to digitalise the issuance and discharge of security deposits, i.e. Banker's Guarantees (BG) / Insurance Bond (IB) to government agencies.

Applying for Banker's Guarantee / Insurance Bond via eGuarantee@Gov

- 3 Shipping companies/ individuals can now apply digital SDs from over 80 Participating Financial Institutions (PFIs) The step-by-step guide to obtain a digital SD is provided below:
- Step 1: Engage one of the <u>Participating Financial Institutions</u> (PFIs) from eGuarantee@Gov
- Step 2: Provide the following information to your PFI, which will process your application and issue/submit the digital SD directly to ICA

Adopting Digital Security Deposit

- With effect from <u>01 April 2025, from 0001 hrs</u>, ICA will only accept digital SD issued from participating Fls under the eGuarantee@Gov initiative.
- We strongly encourage your company to start applying for a digital SD from the participating FIs for a seamless and secured BG issuance process.
