Details : Soil investigation works will be carried out by jack-up barges with the assistance of tugboats.

A safety zone of 30 meters radius must be maintained from the centre of the jack-up barges.

A safety boat will be in attendance at all times to warn and direct craft in the vicinity to keep clear of working area.
