Introduction

1. As announced at Budget 2024, the Energy Efficiency Grant (EEG) will be extended to more sectors by the end of this year. The Maritime and Port Authority of Singapore (MPA) will administer the EEG for the sea transport sector.
2. The base tier of the Energy Efficiency Grant (EEG (Base)) supports the adoption of **pre-approved** energy-efficient port equipment to encourage port operators to transit to energy-efficient port equipment. Only equipment in the pre-approved list will be supported under EEG (Base) for the sea transport sector. The pre-approved list will be made publicly available when the EEG for the port equipment sector commences.
3. MPA is therefore issuing this Request for Information (RFI) to collect information on battery powered forklift of up to 5-ton class for assessment to be pre-approved under EEG (Base). Interested vendors are invited to submit the details of battery powered forklift to be considered for this pre-approved listing.

Submission of information

4. This RFI is a mechanism for gathering information for suitable battery-powered forklift for port-use. Information of the equivalent of diesel-powered forklift is required for comparison purposes. This RFI does not constitute a procurement.
5. Interested parties are requested to submit the product information, including data sheet of both battery-powered and diesel-equivalent, using the attached template. MPA RFI_v1.xlsx
